1.0	INTRODUCTION				
1.0.1	The Thames Valley District School Board (hereafter referred to as the TVDSB) invites interested parties to submit sealed submissions in response to this bid document. The TVDSB is one of the largest public school boards in the Province of Ontario and is comprised of all public schools within the counties of Elgin, Middlesex, and Oxford. The major cities include London, Woodstock, Ingersoll, Strathroy and St. Thomas. The TVDSB is the employer of approximately 8,000 staff and operates 160 schools with an estimated enrolment of 76,000 students.				
1.1	PURPOSE				
1.1.1	The purpose of the consulting engagement is to conduct a needs assessment for TVSDB's telephony system and to make recommendations to TVDSB regarding the optimal enterprise telephony architecture solution to meet the identified telecommunication needs and future potential. This will entail surveying the various stakeholders (teachers, administrators, Board office staff, community groups) and report on the applicability of potential solutions available to meet the collective needs of the Board. The successful proponent will also need to conduct an analysis of the existing telephony architecture and inventory of existing hardware and software and networking architecture. Lastly, the successful proponent will be expected to develop and submit a final report with detailed recommendations and costing analysis of the various telecommunication solutions available that will satisfy the identified needs of the Board.				
1.1.2	The TVDSB may agree to permit other public organizations within Ontario to access any contract(s) that may result from this solicitation. The successful proponent shall allow such access with the understanding that the participating organizations be responsible for their own contract management.				
1.2	BACKGROUND				
1.2.1	The last significant investment in telephony architecture of TVDSB was in 2006/2007 involving VoIP infrastructure installation. TVDSB currently operates a Nortel Telephony system that includes a Nortel CS1000, Call Pilot and a variety of Nortel BCM voice PBXs'. There are approximately 3000 handsets in a mixture of digital and IP sets. All BCM's are connected to the Nortel CS1000 in a hybrid VoIP configuration.
